COUNTY AND DISTRICT FAIRS

CHAPTER ATCP 160

SUBCHAPTER 1

GENERAL REQUIREMENTS AND DEFINITIONS

ATCP 160.01 **DEFINITIONS**, As used in this chapter:

- (1) "Class" means a grouping in which exhibits may be entered, including an animal breed or age group for animal exhibits; a type of produce, crop or food; or specific age, age group or educational grade level of exhibitor.
- (2) "Department," as it relates to the organizational structure of a fair, means an animal species, production group, or other principal classification of exhibits. As used in any other context, "department" means the State of Wisconsin Department of Agriculture, Trade and Consumer Protection.
- (3) "Division" means one of three exhibitor group classifications for a fair and is limited to junior division, open division and senior citizens' division.
- (4) "Lot" or "lot number" means the numerical designation assigned by a local fair for a specific category of exhibits within a class.
- (5) "Premium" means a monetary prize that a county or district fair awards to an exhibitor after judging all competing exhibits in the class to which the premium pertains.

ATCP 160.02 **PREMIUM REQUIREMENTS.**

(1) General.

(a) The state aid authorized by s. 93.23(1), Stats., may be paid only on net premiums, which consist of total premiums paid less total entry fees received. The department may withhold state premium aid from any fair which does not enforce the animal health provisions required under ch. ATCP 10 for all classes of livestock exhibited at the fair.

State aid will be paid only on premiums actually paid by bank check or draft.

(b) No deductions may be made from premium money won by an exhibitor. Premiums may, however, be withheld where exhibition rules established by the fair association are violated. A written statement of violation shall be submitted to the department to justify action taken by a local fair.

(c) Premiums offered shall be definite in amount. No decrease or increase in published premiums may be made because of the financial condition or the organization or for any other reason.

(d) State aid may be paid on no more than 2 premiums awarded an exhibitor under one premium or lot number in open division individual livestock classes, except poultry and rabbits, and no more than one premium in all other classes, including poultry and rabbits.

(e) No county or district fair may receive state aid for a premium awarded to any exhibitor in the open division if that exhibitor entered the same exhibit in the junior division at the same county or district fair. This paragraph does not apply if the exhibit was entered in the junior division only as part of a herd group, carcass class or performance class.

(f) No state aid will be paid on the cost of ribbons, cups, trophy prizes or entertainment contests.

(2) Premium Lists.

(a) Premiums for which state aid is requested by county and district fairs shall conform with the uniform premium list and other requirements set forth in these rules. Fairs requesting state aid for net premiums shall submit to the department a printed copy of the premium list used at the fair, as required under s. ATCP 160.92(3)(c).

(b) The officers of each fair shall mail a copy of the premium list to other associations, societies, or boards conducting a fair in Wisconsin upon request.

(c) Section ATCP 160.01 through 160.07 and 160.91 shall be published in premium books used by a fair for which state aid is requested.

(3) Entry Fees.

(a) A county or district fair may charge an exhibitor an entry fee. The entry fee may not exceed 10% of the sum of all premiums offered to exhibitors in the same class for which the entry fee is charged. In lieu of an entry fee, a county or district fair may charge stall rents for horses, cattle, sheep, goats, swine, poultry, rabbits or pets. Stall rents shall not exceed \$1.50 per single stall or animal or \$3.00 per box stall for horses; \$1.00 per single stall or animal or \$2.00 per box stall for cattle; or 50¢ per animal or \$2.00 per pen for swine, goats and sheep. A standard pen for swine, goats or sheep is approximately 64 square feet. Cage rents may not exceed 50¢ per head for poultry, rabbit or pet exhibits.

(b) Exhibitors in educational and school departments shall not be required to purchase an exhibitor's ticket. Any other exhibitor may be required, if no entry fee is charged, to purchase an exhibitor's season ticket at a price not to exceed that charged for a non-exhibitor's season ticket.

(4) Split Fair Dates.

(a) For purposes of this subsection, "split fair dates" occur when a fair organization judges exhibits or contests and pays premiums at more than one time or at more than one location during the calendar year.

(b) Except as provided under par. (c), the department may not pay state aid for a fair having split dates unless the department gives advance written approval for a split fair. The department may approve split fair dates only if the fair organization justifies the split dates based on extreme hardship. If the department approves split dates, all blue ribbon winners shall repeat their demonstrations or exhibits at the regular fair dates unless the department grants a hardship exemption.

An exhibitor may use audio-visual media, still photography or an educational display to repeat a demonstration or exhibit.

(c) The department may pay state aid for the following exhibits or contests in a fair having split dates, regardless of whether the department approves those split dates in advance:

ATCP 160.03 EXHIBITION REQUIREMENTS. A county or district fair shall meet all of the exhibition requirements of this section to be eligible for state premium aid.

- (1) No fair society or other organization sponsoring a county or district fair shall require an exhibitor to become a member of the organization in order to enter an exhibit at the fair, nor shall the sponsoring organization make any deduction from an exhibitor's premium as a donation to the fair society, or require an exhibitor in any other way to make a donation to the society.
- (2) State aid may not be approved for out-of-state exhibits or for separate classes of local and non-local exhibitors. Aid may not be approved for payment of premiums to an exhibitor having an out-of-state address but claiming Wisconsin residency unless the fair secretary provides the department with an affidavit that the exhibitor's residence is geographically located within the state.
- (3) State aid may be paid only on articles or animals actually on display in an exhibit building or actually shown in the show ring on regular fair dates unless approval for split fair dates is obtained under s. ATCP 160.02(4). State aid may not be paid on Dairy Herd Improvement Association records, transportation aid, production contests or other special educational exhibits unless prior approval is obtained under s. ATCP 160.04(8).
- (4) State aid may not be paid on exhibits removed from the fair grounds before 4 p.m. of the last day of the fair, or such other later time as may be specified by the fair, without prior approval of the department. Authority for earlier removal may be granted by the department in case of meat animal sales or other special classes, if requested before the beginning of the fair. In other hardship cases, approval may be granted by the local fair. Exhibits in dog obedience and small animal pet classes may be judged during the regular fair but are not required to remain present during the entire fair. The local fair may prescribe the length of time junior fair exhibitors of horses shall keep their animals on the grounds.

ATCP 160.04 JUNIOR FAIR DIVISION: GENERAL REQUIREMENTS.

- (1) Eligibility. In the junior fair division, the department may pay state aid on prizes offered to exhibitors who are under 20 years of age on January 1 of the current fair year. A county or district fair board may establish subgroups within a fair entry class based on the exhibitor's grade level in school. The department may not pay state aid on prizes for club parades, club floats, song contest, or a project which is not an exhibit or demonstration at the fair.
- (2) All exhibitors in the junior fair division shall be members of 4-H, FFA, FHA-HERO, Scouting programs, breed groups, or any other recognized youth organization under adult leadership and with an education program approval by the local fair.
- (3) Exhibits in the junior fair shall be a result of the exhibitor's own labor and may include a study, merit, or other special project, a skill area or a supervised occupational experience in which the exhibitor is regularly enrolled.
- (4) State aid may be used for the payment of no more than one premium awarded an exhibitor under any one premium or lot number in the junior fair division, except when awarded as part of a group in livestock exhibits or in showmanship.
- (5) Premiums in the educational department shall be paid directly to the exhibitor who made the exhibit and not to the school or teacher, except for group premiums offered to inter-school competitive classes. No aid may be paid on education department premiums unless a complete list of exhibitors and a complete set of judges' sheets for the education department, similar to those required in other departments, is filed with the department. All educational exhibits shall be displayed at the fair regardless of whether they are judged prior to or at the fair.
- (6) If 16 or more animals, items or articles are entered in any junior fair class, the class may be divided into 2 or more approximately equal groups according to weight, age or other identifying characteristic and each group judged as a class.
- (7) Special education exhibits may be established if the proposal is presented to the Wisconsin association of fairs before October 1 of the year preceding its proposed establishment and the exhibit is approved by the department.
- (8) Within any junior fair department under subch. IV, a county or district fair may establish special classes where none are specified under sub ch. IV. Special classes may include classes for grade and crossbred females in the beef, swine, sheep and horse departments. Premiums for special classes created under this subsection shall be equal to premiums for comparable classes established in the same department under sub ch. IV.

ATCP 160.05 OPEN DIVISION: GENERAL REQUIREMENTS.

- (1) The total maximum premiums set forth for all places in any open division livestock class, excluding poultry and rabbits, may be divided into premiums for a greater number of places, but the maximum premium offered for any additional place shall be not higher than the maximum for last place in the class.
- (2) State aid for premiums awarded for horses in open division classes shall be limited to horses which are owned by the exhibitor.
- (3) All animals in any open division class shall be owned by the exhibitor, except as provided in s. ATCP 160.09.

ATCP 160.06 SENIOR CITIZENS DIVISION: GENERAL REQUIREMENTS.

- (1) The age of exhibitors in the senior citizens division is limited to persons 62 years of age or over.
- (2) Exhibitors in the senior citizens division may not enter identical items or articles in both the senior citizens division and the corresponding classes of the regular open division.

ATCP 160.07 CLASSES: GENERAL REQUIREMENTS.

- (1) Classes may be combined if the number of entries in several single classes is insufficient. If any classes are combined, state aid shall be limited to the maximum total premiums listed for a single class of animals, items or articles in that department.
- (2) (a) Except as provided under par. (b), no county or district fair may receive state aid for premiums awarded for sexually intact male dairy cattle, beef cattle, sheep, goats, swine or horses unless those animals are registered purebreds. Registered purebred status shall be documented by a certificate of registry from the appropriate breed association or society, or by a copy of the application for registration.
- (b) Paragraph (a) does not apply to dairy cattle exhibited at a county or district fair if a national breed association certifies that those dairy cattle are recorded in that breed association's qualified herd book which records the genealogy of that breed.
- (3) Any animal entered as part of a group class may also be exhibited in a class for individual animals.
- (4) Boars may not be entered as an exhibit in the swine department unless their tusks have been removed.

ATCP 160.91 - JUDGING REGULATIONS

- (1) Judging shall be done at county and district fairs by individuals who are registered with the department and who have knowledge, training or experience in the specific class or classes to be judged as determined by the department. Judging shall be done in accordance with the requirements of s. ATCP 160.92(3)(a). In no case shall any person who is an officer or director of a fair be eligible to judge exhibits at such fair; nor shall any person interested directly or indirectly in exhibits shown in any department of a fair be eligible to judge articles or animals in that department.
- (2) Each judge at a county or district fair shall be provided with a copy of the fair's premium book or list of entry classes at least 7 days prior to the opening date of the fair.
- (3) No animal or article, irrespective of the number of entries in the class in which it is entered, shall be awarded a higher rating than its merit would entitle it to in comparison to the standard of perfection in the class.
- (4) (a) No state aid will be paid on premiums awarded under the Danish system in any classes except in the junior and educational departments.
- (b) When classes in the junior and educational departments are judged according to the Danish system, 4 group placings shall be awarded in any class. When there are less than 8 exhibitors in the class, there shall not be more than 2 in the first group, not more than 4 in the first 2 groups and not more than 6 in the first 3 groups. If there are 8 or more entries in the class, there shall not be more than 25% in the first group, not more than 50% in the first 2 groups and not more than 75% in the first 3 groups.
- (c) The number of awards in the last group placing may be increased to the extent necessary to give awards to all exhibitors.
- (5) If any class of exhibits at a county or district fair is judged according to the regular system, the judges for that class may give only one first-place, one second-place, one third-place and one fourth-place award in that class.

SPECIAL RULES

1. Entries must be postmarked no later than Friday, June 29, 2018. A fee of \$2.00 will be charged for an exhibitor's season ticket.

2. Stall or pen rent for the livestock classes shall be:

Cattle — \$1.00 per head

Swine, Sheep and Goats — 50¢ per head

Poultry & Rabbits — 50¢ per head

3. All items for exhibit must be the current year's project work.

No person shall be entitled to a premium who was not the bonafide owner of the property at the time of entry. Exhibitor grade is determined on January 1 of the current year.

4. Only articles listed in the handbook may be exhibited. Only ONE item may be exhibited on an entry number unless specifically allowed (i.e. Pen of Wethers).

5. Entries must be on the fairgrounds and in their proper places, properly ticketed, by FRIDAY at 5:00 p.m. of the Fair. The only exceptions to this rule shall be flower and food exhibits, which are to be on the grounds not later than 9:00 a.m. on the Saturday of the Fair. If these conditions are not complied with, no premiums will be awarded.

6. The Fair Board is not responsible for exhibits shipped or mailed to the Fair. All exhibitors must bring their exhibits to the fairgrounds on Friday and remove them from the grounds on Sunday. No exhibits will be accepted by mail.

7. Call for tags and exhibitor's tickets at the Secretary's Office on opening day. Entry tags must be attached by the exhibitor when exhibits are brought in.

8. Report to the Department Superintendent for instruction and assignments to stalls, pens or spaces.

9. Exhibitors must furnish their own feed and bedding, unless otherwise stated.

10. Livestock exhibitors shall have a copy of the required health certificate or test reports available for inspection by the Department at the Fair or file a copy of such certificate or test reports at the fair office for the duration of the exhibit.

11. Each exhibitor is to show his own animal(s).

12. Responsibility for grooming animals for show is the responsibility of the exhibitor. Clipping, trimming or blocking by anyone other than the exhibitor or any Wisconsin junior exhibitor will not be permitted. Violation automatically disqualifies the exhibitor.

13. Any inappropriate appearance altering — coloring, surgery, addition of hair or treatment (medical or physical, external or internal) shall result in disqualification of exhibit and/or exhibitor as proper authorities deem appropriate.

14. Any equipment or inappropriate attire on an exhibitor or animal judged by the Department Superintendent to be detracting from the appearance of the show shall be changed upon request. For clarification, review the 4-H literature for beef, sheep and swine fitting and showing.

15. Entries will be judged by Danish system, unless otherwise stated.

16. Premiums are paid only from awards made by judges as they appear on the judges' sheets and not from ribbons attached to the exhibit. Judging sheets are the only official records of correct awards; ribbons may be misplaced or tampered with.

17. Exhibitors are requested to pay particular attention to their article(s) or animal(s) on exhibition and take charge of the same. The Fair Board will take every precaution for their safekeeping, but is not responsible for lost, damaged or stolen articles or exhibits. Exhibitors will be held responsible for any damage or accident which may be caused by their entries.

18. The Fair Board is not responsible for articles or exhibits left on the fairgrounds at the close of the Fair.

19. The Fair Board reserves the final and absolute right to interpret these Rules and arbitrarily settle and determine all matters, questions and differences connected with an incident related to the Fair.

20. Due to state budget concerns, premiums may be adjusted prior to the Fair

REMOVAL OF EXHIBITS

Exhibits must **not** be removed from the exhibition space until 4:00 p.m. of the last day of the Fair, according to State laws governing fair premiums. Entries should be removed by 4:30 p.m. unless arrangements are made with the Department Superintendent.

FAIR SUPERINTENDENT RESPONSIBILITIES

- (1) Be familiar with the rules and regulations of the Fair.
- (2) Be responsible for the orderliness, placement and upkeep of exhibits in the assigned exhibit areas.
- (3) Be familiar with the PREMIUM LIST in their department(s).
- (4) Be familiar with the system of judging which is used in their department(s), Danish or regular.
- (5) Be responsible for seeing that the judges' sheets are properly filled out and signed.
- (6) Inform the judge that exhibits not meeting the necessary requirements will automatically be awarded a fourth placing.
- (7) Be responsible for developing suggestions and comments in regard to judges, exhibits and fair book that will help improve future exhibits and fairs.
- (8) Pick up trophies, ribbons and other materials from the Office.
- (9) Write down judges comments on exhibitor cards. Encourage judges to give comments that will help the exhibitor improve on his/her skills.
- (10) Establish, communicate and monitor show and judging procedures.
- (11) Monitor and report violations of the Blake's Prairie Jr. Fair Code of Conduct. Document verbal warnings and other actions taken by the Superintendent as a result of violations of the code of conduct.

CODE OF CONDUCT

Anyone attending the Blake's Prairie Jr. Fair either as an exhibitor, parent, spectator, superintendent, judge or fair official must conduct themselves in a manner consistent with the following International Association of Fairs and Expositions Code of Show Ring Ethics and the Addendums to the code listed below.

These codes of conduct are not limited to the show ring, but are applicable to all departments, activities and events associated with the Blake's Prairie Jr. Fair. Consequences to violating this code of conduct may include, but are not limited to:

- Verbal warning
- Written warning
- Removal from Fairgrounds
- Suspension, reduction and/or loss of premiums
- Suspension, reduction and/or loss of auction proceeds
- Loss of future show privileges
- Notification to local fairs as to disciplinary actions taken

INTERNATIONAL ASSOCIATION OF FAIRS AND EXPOSITIONS (IAFE) CODE OF SHOW RING ETHICS

Exhibitors of animals at livestock shows shall at all times deport themselves with honesty and good sportsmanship. Their conduct in this competitive environment shall always reflect the highest standards of honor and dignity to promote the advancement of agricultural education. This code applies to junior as well as open class exhibitors who compete in structured classes of competition. This code applies to all livestock offered in any event at a livestock show. In addition to the "IAFE Code of Show Ring Ethics," fairs and livestock shows may have rules and regulations that they impose on the local, county, state, provincial and national levels.

All youth leaders working with junior exhibitors are under an affirmative responsibility to do more than avoid improper conduct or questionable acts. Their moral values must be so certain and positive that those younger and more pliable will be influenced by their fine example. Owners, exhibitors, fitters, trainers and absolutely responsible persons who violate the code of ethics will forfeit premiums, awards and auction proceeds and shall be prohibited from future exhibition in accordance with the rules adopted by the respective fairs and livestock shows. Exhibitors who violate this code of ethics demean the integrity of all livestock exhibitors and should be prohibited from competition at all livestock shows in the United States and Canada.

The following is a list of guidelines for all exhibitors and all livestock in competitive events:

- 1) All exhibitors must present, upon request of fair and livestock show officials, proof of ownership, length of ownership, and age of all animals entered. Misrepresentation of ownership, age, or any facts relating thereto is prohibited.
- 2) Owners, exhibitors, fitters, trainers, or absolutely responsible persons shall provide animal health certificates from licensed veterinarians upon request by fair or livestock show officials.
- 3) Junior exhibitors are expected to care for and groom their animals while at fairs or livestock shows.
- 4) Animals shall be presented to show events where they will enter the food chain free of volatile drug residues. The act of entering an animal in a livestock show is the giving of, consent by the owner, exhibitor, fitter, trainer and/or absolutely responsible person for show management to obtain any specimens of urine, saliva, blood, or other substances from the animal to be used in testing. Animals not entered in an event which culminates with the animal entering the food chain shall not be administered drugs other than in accordance with applicable federal, state and provincial statutes, regulations and rules. Livestock shall not be exhibited if the drugs administered in accordance with federal, state and provincial statutes, regulations and rules affect the animal's performance or appearance at the event.
If the laboratory report on the analysis of saliva, urine, blood, or other sample taken from livestock indicates the presence of forbidden drugs or medication, this shall be prima facie evidence such substance has been administered to the animal either internally or externally. It is presumed that the sample of urine, saliva, blood, or other substance tested by the laboratory, to which it is sent, is the one taken from the animal in question, its integrity is preserved and all procedures of said collection and preservation, transfer to the laboratory and analysis of the sample are correct and accurate and the report received from the laboratory pertains to the sample taken from the animal in question and correctly reflects the condition of the animal at the time the sample was taken, with the burden on the owner, exhibitor, fitter, trainer, or absolutely responsible person to prove otherwise.
At any time after an animal arrives on the fair or livestock show premises, all treatments involving the use of drugs and/or medications for the sole purpose of protecting the health of the animal shall be administered by a licensed veterinarian.
- 5) Any surgical procedure or injection of any foreign substance or drug or the external application of any substance (irritant, counterirritant, or similar substance) which could affect the animal's performance or alter its natural contour, confirmation, or appearance, except external applications of substances to the hoofs or horns of animals which affect appearance only and except for surgical procedures performed by a duly licensed veterinarian for the sole purpose of protecting the health of the animal, is prohibited.
- 6) The use of showing and/or handling practices or devices such as striking animals to cause swelling, using electrical contrivance, or other similar practices are not acceptable and are prohibited.
- 7) Direct criticism or interference with the judge, fair or livestock show management, other exhibitors, breed representatives, or show officials before, during, or after the competitive event is prohibited. In the furtherance of their official duty, all judges, fair and livestock show management, or other show officials shall be treated with courtesy, cooperation and respect and no person shall direct abusive or threatening conduct toward them.
- 8) No owner, exhibitor, fitter, trainer, or absolutely responsible person shall conspire with another person or persons to intentionally violate this code of ethics or knowingly contribute or cooperate with another person or persons either by affirmative action or inaction to violate this code of ethics. Violation of this rule shall subject such individual to disciplinary action.
- 9) The application of this code of ethics provides for absolute responsibility for an animal's condition by an owner, exhibitor, fitter, trainer, or participant whether or not he or she was actually instrumental in or had actual knowledge of the treatment of the animal in contravention of this code of ethics.

10) The act of entering an animal is the giving of consent by the owner, exhibitor, fitter, trainer, or absolutely responsible person to have disciplinary action taken by the fair or livestock show for violation of this Code of Show Ring Ethics and any other rules of competition of the fair or livestock show without recourse against the fair or livestock show. The act of entering an animal is the giving of consent that any proceedings or disciplinary action taken by the fair or livestock show may be published with the name of the violator or violators in any publication of the International Association of Fairs and Expositions, including Fairs and Expos and any special notices to members.

11) The act of entering of an animal in a fair or livestock show is the giving of verification by the owner, exhibitor, fitter, trainer, or absolutely responsible person that he or she has read the IAFE Code of Show Ring Ethics and understands the consequences of and penalties provided for actions prohibited by the code. It is further a consent that any action which contravenes these rules and is also in violation of federal, state, or provincial statutes, regulations, or rules may be released to appropriate law enforcement authorities with jurisdiction over such infractions.

BLAKE'S PRAIRIE JR. FAIR CODE OF CONDUCT ADDENDUMS

A1. In addition to showing and/or handling practices outlined in the IAFE Code of Show Ring Ethics, animal cruelty or abuse of any kind is strictly prohibited.

A2. Anyone attending the Blake's Prairie Jr. Fair either as an exhibitor, parent, spectator, superintendent, judge or fair official must conduct themselves in a manner that demonstrates the utmost respect for other parents, exhibitors, superintendents, judges and fair officials. They are to follow instructions with regard to show and judging procedures as outlined in the premium handbook and by judges, superintendents and fair officials.

A3. Parents have a special responsibility to set positive examples and serve as a positive role model for youth by what they do and say. This includes, but is not limited to conducting themselves in a manner that demonstrates the utmost respect for other parents, exhibitors, superintendents, judges and fair officials. They are to follow instructions with regard to show and judging procedures as outlined in the premium handbook and by judges, superintendents and fair officials.

A4. The Blake's Prairie Fair Association may act on conduct violations at any time during or after the fair. The Board of Directors will provide written communication as to application of consequences for violating the code of ethics. That communication will allow a 10 day period from the date of the letter in which the letter recipient must notify the Board in writing of their intent to appeal. The appeals committee will be chaired by the Grant County Youth Development Educator and will include a member of the Grant County 4-H Leaders Executive Committee, a Blake's Prairie Fair Board member and a Fair Superintendent. The appeals committee will hold a hearing and make a recommendation to the entire Board who will consider the recommendation of the appeals committee and report its final decision to the appealing party within 45 days of receiving their letter of intent to appeal.

 - (f) A winter yearling is one whose date of birth is between December 1 of the second year preceding the exhibit year and February 28 or 29 of the year preceding the exhibit year.
 - (g) A fall yearling is one whose date of birth is between September 1 and November 30 of the second year preceding the exhibit year.
 - (h) A 2-year old is one born between September 1 of the third year preceding the exhibit year and August 31 of the second year preceding the exhibit year. A 2-year-old includes a yearling that has freshened.
 - (i) A 3-year old is one whose date of birth is between September 1 of the fourth year preceding the exhibit year and August 31 of the third year preceding the exhibit year.
 - (j) A 4-year old is one whose date of birth is between September 1 of the fifth year preceding the exhibit year and August 31 of the fourth year preceding the exhibit year.

Sale will be auction on hoof and will be open to packers and the public on Saturday, July 15, at 3:00 p.m.

Advance entry deadline, Saturday, June 29 2017. **NO ENTRIES WILL BE ACCEPTED AFTER THIS DATE.** Special consignment blanks are available in the center of this Exhibitor Handbook.

4-H and FFA members who have completed third grade through the year following high school graduation, if eligible to show, are able to sell at this sale, providing they have not sold an animal at another fair in Grant County this year.

Animals sold in this sale need not have been identified and recorded in Grant Co. Extension Office.

Livestock sold must meet the following requirements:

Beef – Graded on Saturday by judge – must grade select or above–950 lbs. or over

Lamb Wethers – U.S. Prime or U.S. Choice from 90 lbs. to 150 lbs.

Market Pigs – U.S. No. 1 or U.S. No. 2 – must weigh at least 220 lbs. and under 300 lbs. – those over 280 lbs. will be sold at 280 lbs.

Goat Wethers – May be sold up to one year of age.

Rabbits and Poultry - The requirements of department market classes.

JUDGE'S DECISION IS FINAL.

Each 4-H and FFA member may consign and sell a maximum of one (1) species of livestock (either beef, sheep, swine, goats, poultry or rabbits) and not more than one (1) head of the species they select can be auctioned.

Exhibitors that have consigned particular species of livestock and are awarded the Champion or Reserve Champion in another species will be given the option of selling the original consignment or the Champion or Reserve Champion. Under no conditions will exhibitors be permitted to sell more than one animal.

Exhibitor can sell at only one fair in Grant County.

ELIGIBILITY OF ANIMALS

Any animal sold at the meat animal auction may be shown after the auction only with permission of buyer. This intent shall be made known at sale time.

Steers, wether or barrows showing masculine coarseness or evidence of late and/or incomplete castration will be discriminated against by the judge.

An animal that becomes wild and uncontrollable during the show may be declared ineligible by the Department Superintendent.

A market animal must have been shown alive to be eligible for carcass awards and premiums.

SHOW AND SALE PROCEDURES

All consigned animals must show in the regular Junior Classes of the Blake's Prairie Fair. There will be no special classes for sale animals.

Members must be able to lead and present his/her own animal in the sale ring, unless special permission is granted by the Sale Superintendents. If an animal presented in the sale ring by someone other than the exhibitor without permission from the Livestock Auction Committee, all proceeds from that animals sale will be forfeited and returned to the buyer.

Steers, market pigs and wethers will be weighed on Friday, between 10:30 a.m. and noon. This weight minus 3% shrink will be used for the sale weight of steers. Market pigs, lambs and steers will sell in the order they placed in their show. All meat animal sale exhibitors must be available to have pictures of livestock taken with buyer immediately following sale if requested. A consignment fee of 2% of the sale price must be paid at the time of payment, following the auction. Fees will be used to build a fund to cover promotion, advertising and expenses related to the show and sale.

All livestock sold at this sale will not become the possession or the responsibility of the buyers until 4:00 p.m. on Sunday. Payments will be sent directly to the sellers.

MANDATORY CHECK OFF ON SWINE AND BEEF

All market pigs and steers sold in the Livestock Auction will have a mandatory check-off at the rate of \$1 per head for steers and .45 of one percent of the actual selling price for market pigs deducted from the sale price.

CARCASS SHOW EVALUATION
Bloomington Meats - July 18 at 7:00 p.m.

An exhibitor may enter one market animal shown at the Fair.

Members planning to participate in the Carcass Show Evaluation must include this Class entry, for the correct livestock department, on a regular Entry Blank with other entries. However, if the animal is sold at the Meat Animal Sale, entry is at the discretion of the buyer.

Premiums will be included in the exhibitor's total premium check.

Butchering will be done on Monday, July 24. First-place trophies will be awarded to Steer, Swine and Lamb. A carcass must grade Choice to receive a trophy in any department.

Attendance at the Evaluation is suggested for all exhibitors who have entered a carcass class.

LIABILITY

It is understood that all persons participating in this show, acting on behalf of themselves, their principals, their agents or employees, agree to make no claim against the "show," any official of the show or anyone acting by, for or through them, for loss, damage or injury to any property, animal or person resulting from any cause. All animals, exhibits, grounds and buildings shall be under the entire control and management of the "Show" but neither the "Show" or any of its officers or employees will in any case be held responsible for any loss or damage that may occur to any livestock exhibited.

ALL LIVESTOCK EXHIBITED SHALL BE AT THE SOLE RISK AND RESPONSIBILITY OF THE EXHIBITOR.

FRAUD

The management reserves the right to withhold the premiums awarded in any case in which it shall appear that the regulations have not been complied with, or that fraud or deception has been practiced or attempted. Payment for beef, swine and lambs sold in the auction to local packing plants will not be made until carcasses have been inspected in the coolers. Any carcass showing evidence or antemortem tampering, will be paid for in accordance with their market worth, regardless of auction price of the live animal. Ribbons, medals and prizes awarded on such animals shall be forfeited and the exhibitor shall be banned from future showing.

WHOLESOMENESS OF THE MEAT PRODUCT

All exhibitors and their parents or guardians must sign a form attesting to the proper withdrawal of all additives and injections administered to the animals being shown. All Champion and Reserve Champion animals going to slaughter will have tissue samples collected and submitted to the State Laboratory by the State Meat Inspectors. The exhibitor will pay the cost of the sample analysis.

COMPLAINTS

Any complaints regarding eligibility of entries SHALL be filed in WRITING. This complaint will be filed by an exhibitor with the Department Superintendent. There is a charge of \$5.00 which must be paid when filing such complaint.

APPEALS

Before any exhibitor is disqualified he or she shall be granted the right to meet with the show authorities on the potential disqualification.
